Updates

Old Business

Friends of Reid State Park (FRSP)

- Haylee Parsons & Gary Best (Maine State Parks Southern Region Manager) participated in the Advisory Group of FRSP. The team is focusing on two initial areas– The Old School House and a "Learning Center" which will eventually be housed in the concession stand building at Griffiths Head.
- The Old School House presents quite a challenge since the roof has holes, many trees are unstable and brush is surrounding the building. Gary and Haylee will bring in the State Maintenance Department to assess the building and make stabilizing repairs. They will also seek advice from the ME State Preservation Commission for what can and can't be done if it is considered a historical building.
- There are many opportunities to enhance interactive educational programs, both existing and future. The desired plan is to eventually create a Learning Center in this space; funding is allocated through the American Recovery Program Act. A subcommittee was formed to develop a plan and identify what work can be done to support existing programs and see if there are new opportunities in the shorter term. Haylee and Gary have experience and expertise in this area and several members of the team bring considerable skills in this area. In the meantime, plans can be made that don't require a building. Programs of interest include:
 Critter of the week
 - Plaques along the wood trails

o Jr. Ranger Program

- A long range idea is to turn the bath house at Todd's Point into an Event Center. A modified approach to the bathhouse is also being considered.
- Mats are available but where they will be used is not determined at this time. They will make access to beach area easier for those with limited mobility. East Beach (by the Pavilion) seems to be the best choice since Mile Beach is steep and erosion created rock exposure at Half Mile Beach.
- Currently the reopening date of the park is being pushed back a bit due to delays in bridge construction material deliveries and the infrastructure and new booths at the entrance area.

Community Yard Sale

- Miriam Nesset will be point person for the 2023 Community Yard Sale August 26 outside the First Church. More details later.
- GCC & our Fire Dept. are also having yard sales this summer. The AFG sale will offer space for residents to do their own selling.

Alzheimer's/Dementia Program

- Elizabeth Gattine from the State Cabinet on Aging met with members of AFG steering committee. She listened and took note of our concerns:
 - Possibility of having a contact person at the State level who can direct people to correct office to call to address their issue.
 - Find a way to create a 'good Samaritan' insurance to cover Job Squad. We presently use liability waivers for both the Job Squad volunteers and the resident being helped.
 - Use of trade school students to step into 'plumber', and 'electrician' roles for Job Squad.
 - Georgetown has received a Community Action Grant for Town energy audits which provides funding for improvements to town buildings. At our June meeting, Jessica Weller will address ways AFG can help support this effort.
- Transportation/Accompanying Friends to Dr. Appointments What can AFG do? Suggestion made to record sessions with the Dr. and pass on to care giver.
- Affordable Housing in Georgetown Ideas
 - Work Force Housing compensate homeowner for 'renting a room' to a summer employee. We will connect with the Workforce Housing group to see if we can help.
 - Match Ups S. Portland residents w/ Southern ME Community College.
 - Home Share (Vermont)
 - Chebeaque Island tiny houses
 - Issues in Georgetown around zoning, HOA covenants in some areas, acreage, shoreline zoning, cultural concerns, sustainability.
 - Should there be a Tide article to let residents know AFG remains concerned about housing and is willing to work cooperatively with others?
- Gleaning

The gleaning table will probably start in late May. Some local gardeners donate produce and are already planting.

Other
